I (we) agree to hold the AKC and any AKC approved judge harmless from any legal claim resulting from said AKC Judge's action under the AKC Rules, Regulations and Guidelines. I (we) agree that the club holding this show or obedience trial has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of holding of the show or obedience trial and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies. 2. The following categories of dogs may be entered and shown in Best of Breed competition. Dogs that are Champions of Record and dogs which according to their owners (records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Bred competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Dog Show Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog. i.e. age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for the show closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. 3. (Dog Show Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog. i.e. age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for the show closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
